Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>BHA has participated in 2 community lead groups working towards ending homelessness in Bremerton.</p> <p>The first group was “Homes for all”. This group met regularly to address the housing needs of homeless vets. The goal was to house every documented homeless vet. The group started meeting at beginning of 2017 and the goal was met by the end of 2017. BHA attended outreach events and worked to ensure that all VASH vouchers were in issued.</p> <p>The second group was “Housing First”. This group was made up of local agencies who all have a similar mission of ending homelessness. Kitsap County as most areas are facing a serious homeless problem. In the 2016 Homeless Housing Plan details the needs of homeless and lack of appropriate resources. There is a lot of interest in the community to develop a Housing First Project. This type of housing has been very successful in other areas. BHA continues to engage in the conversation as a plan is developed and if there is a place in the plan for BHA to partner using project based vouchers BHA would be interested in participating.</p> <p>In 2015 BHA open the Section 8 Housing Choice Voucher waitlist March 3, 2015 and closed it 2 weeks later. BHA took in excess of 3176 applications and placed 300 people on the waitlist through a lottery system. In March of 2016, BHA again opened the waitlist and took another 3807 applications. BHA placed 300 applicants on the waitlist bring the total to 409 applicants. Do to the increase in the market rate rents and lack of additional funds BHA has been in holding pattern but in 2018 there will be movement on the waitlist. The goal is to reopen the waitlist in March of 2019.</p> <p>BHA received an additional 28 VASH vouchers in 2018 and have begun issuing the vouchers to veterans referred to BHA via American Lake.</p> <p>BHA will begin self-management on BHA owned properties in the fall of 2018. BHA will maintain all aspects of property management and tax credit requirements.</p>

E. Statement of Capital Improvements. PHAs that receive funding from the Capital Fund Program (CFP) must complete this section. (24 CFR 903.7 (g))

E.1 Capital Improvements. In order to comply with this requirement, the PHA must reference the most recent HUD approved Capital Fund 5 Year Action Plan. PHAs can reference the form by including the following language in Section C. 8.0 of the PHA Plan Template: "See HUD Form 50075.2 approved by HUD on XX/XX/XXXX."
